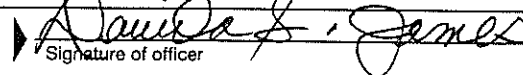

This amount includes office supplies, \$175 for board meetings and board development; \$200 as a deposit to start our High Desert Community Foundaton account; Website and domain fees and a \$234.20 deduction for a fraudulent charge on our bank account that has since been credited on June 19, 2014.

Victor Valley Arts and Education Center (VVAEC) is a member (affiliate fund) of the High Desert Community Foundation (HDCF) one of the numerous community foundations across the country that is an umbrella for nonprofits that may or may not have 501c3 status, thereby precluding us from filing taxes on funds that are contributed to us through their foundation or grants we receive under their auspices. HDCF handles the IRS tax reporting for us as one of their affiliate funds. In October, 2013 VVAEC was awarded a \$10,000 grant from The Community Foundation Serving Riverside and San Bernardino Counties in support of a grant we wrote called "Love Letters and Musical Notes" that allowed us to put on several performances for low-income senior citizen centers and housing complexes. As part of this grant, we were able to purchase some basic equipment that has now become part of our inventory for the nonprofit. There was minimal impact to funds in our own bank account as the purchases were made from the grant funds. This inventory now includes a wireless PA system, microphones, chairs, scripts and tables that amount to \$752.66. In addition, we had one contributor who donated a Brother MFC-7220 Laser Printer (value \$408.99) and a case of paper (\$53.00). These three amounts total \$1,215.00

**PART III: LINE 28: \$88.00**

The accounting for the \$10,000 grant we received was done by our High Desert Community Foundation. But this grant allowed us to produce and perform our first set of performances as a startup arts organization in our community. We presented the play "Love Letters" by A.R. Gurney at the Victorville Senior Citizen's Center, the Adelanto Senior Citizen Center, Hesperia Senior Living Center and the Village Oaks Apartments in Victorville, CA. Each of these were performed in low-income, racially diverse communities. In three of the venues, VVAEC trained novice actors to perform in the play. In addition, we presented the play "Steel Magnolias" for the women from "A Better Way Domestic Violence Shelter." We also had the play translated into Spanish, but due to casting problems, that performance was cancelled. While the total number served in both audience members and participants for all performances was less than 200, we are

heartened by the fact that our surveys after each performance indicated that we had fulfilled the purpose of the grant by bringing an arts event to an underserved population. We had several audience members, including one 93-year-old woman indicate that they had never seen a live theatrical performance. We also had several hearing-impaired people attend and sign for each other at the performance at Hesperia Senior Living. The \$88.00 reflects very minor expenses we incurred outside of the grant funds.
